Subject: -Regularization of admission made by Prem Raghu Ayurvedic Medical College and Hospital, Near M.G. Polytechnic College, Agra Road, Distt. Hathras-204101, Uttar Pradesh (Inst. ID-AYU0378) as per the permissible intake capacity in UG (BAMS) course for the academic session 2020-21, in compliance of the Court order dated 31.05.2023 passed by the Hon'ble High Court of Delhi in the W.P.(C) No. 4126/2021-reg.

Sir/Madam,

I am to refer to the Ministry's order ref. no. **L-14014/34/2020-EP-1** dated **02.02.2021** vide which conditional permission of your college was denied to take admission with 60 seats in **UG (BAMS) course** under Section 13C of IMCC Act, 1970 and concerned regulations thereunder, for the academic session 2020-21.

Further, you challenged the aforesaid Ministry's order ref. no. **L-14014/34/2020-EP-1** dated **02.02.2021** before the Hon'ble High Court of Delhi and filed **W.P.(C) No. 1622/2021**. In accordance with the order of **The Hon'ble High Court of Delhi in W.P.(CW)2110/2021 & connected matters with W.P.(C) No. 1622/2021**, an opportunity of hearing was granted to your college clarify on the shortcomings mentioned in the denial letter dated **02.02.2021**. Further, based on the hearing, denial of permission for taking admission with 60 seats in **UG (BAMS) course** under section 13C of IMCC Act, 1970 and concerned regulations thereunder, for the academic session 2020-21 was issued again to you and the same was communicated vide letter ref no. **L-14014/34/2020-EP-1** dated **22.03.2021**.

Further, aggrieved by the said order dated **22.03.2021**, once again you approached the Hon'ble High Court of Delhi and filed another writ petition vide WP (CW) No. **4126/2021** and Hon'ble Court of Delhi vide its final order dated 31.05.2023 disposed off the writ petition and set aside the above denial order dated **22.03.2021** passed by the Ministry of Ayush and in relevant para held as under:-

"42. In such circumstances, I am of the view that the petitioners can be granted a consequential order continuing the students who have already been admitted, but not to any further relief, whether by way of remand, further counseling, or otherwise.

43. In the light of the above, and following the decision of this Court in Anil Kumar Singh Bhadoria, the impugned decisions of the Union of India are set aside, and the petitioners are permitted to continue with the admission of the students who were admitted pursuant to the interim orders passed by this Court.

44. In the facts and circumstances of the case, no further relief is considered appropriate.

45. The writ petitions and all the pending applications are disposed of with these directions"

Accordingly, as per the direction of President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM), the aforesaid matter was placed in the **69th Board meeting** of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) held on **07.11.2023** and Board decided to regularize the admission made by the Prem Raghu Ayurvedic Medical College and Hospital, Near M.G. Polytechnic College, Agra Road, Distt.

Hathras-204101,Uttar Pradesh (Inst. ID-AYU0378) as per the permissible intake capacity in UG (BAMS) course for the academic session 2020-21, in compliance of Hon'ble High Court of Delhi order dated 31.05.2023 passed in W.P.(C) No. 4126/2021.

Therefore,in compliance of the Hon'ble High Court of Delhi order dated 31.05.2023passed in W.P.(C) No. 4126/2021, the admission made by Prem Raghu Ayurvedic Medical College and Hospital, Near M.G. Polytechnic College, Agra Road, Distt. Hathras-204101,Uttar Pradesh (Inst. ID-AYU0378) is hereby regularized as per the permissible intake capacity in UG (BAMS) course for the academic session 2020-21. Hence, the earlier order of Ministry vide ref. no. L-14014/34/2020-EP-1 dated 22.03.2021 for the academic session 2020-21 stands null and void.
