**Subject:- Regularization of admission of admitted students in Prem Raghu Ayurvedic Medical College and Hospital, near M.G. Polytechnic College, Agra Road, Distt. Hathras-204101, Uttar Pradesh (AYU0378) in UG (BAMS) course under section 28 of the NCISM Act, 2020 for the academic session 2021-22.- regarding.**

Sir/Madam,

With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provision of National commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act, 1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-division (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) shall stand dissolved. Now, in exercise of the powers conferred by sub-section (3) of the section 1 of the said Act, the Central Government hereby notifies that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021.

1. That **Prem Raghu Ayurvedic Medical College and Hospital, Near M.G. Polytechnic College, Agra Road, Distt. Hathras-204101, Uttar Pradesh** was denied permission for conducting UG (BAMS) course for the academic session 2021-22, under section 13C/13A of the IMCC Act, through Ministry's order vide ref no. **F. No. L.14014/10/2022-EP-1 dated 24.03.2022** due to various shortcomings.
2. That the college had challenged the above mentioned denial of permission order dated 24.03.2022 passed by Ministry of Ayush before the Hon'ble High Court of Delhi, at New Delhi in W.P. (C) No. 6499/2022.
3. That the Hon'ble Court vide its final order dated 12.03.2024, disposed of the writ petition and directed the respondents (NCISM) to regularise the **5 students admitted in academic year 2021-22**. The relevant portion of the order is reproduced here as under: -

*"15. In these circumstances, following the view of the coordinate Bench in **Beehive Ayurvedic Medical College and Hospital**, this petition is disposed of by regularising the admissions of the five students who joined the UG (BAMS) course of the petitioner for the year 2021-22."*

4. That the college vide ref no. **PRAMCH/314/08/2025 dated 18.08.2025** informed the President MARBISM as under:-

*"With great respect I, Principal Prem Raghu Ayurvedic Medical College and Hospital (AYU0378) Agra Road, Hathras (UP) want to say that our college has not got the permission letter for session 2021-22 UG BAMS course from the NCISM. While Sir in the session 2021-2022 High Court gave the decision in*

the favour of the admitted students in BAMS course. That the students who are admitted in session 2021-2022 through the counselling are permitted to continue their study. The High Court order copy in enclosed with the letter."

5. Thereafter, the matter was placed in the **146<sup>th</sup> Board meeting** of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) held on **10.09.2025**. The Board discussed and decided to regularize the students already admitted for UG (BAMS) course in the college for the Academic Year 2021-22 **to protect the interest and future of the students.**
6. Therefore, the admissions made by **Prem Raghu Ayurvedic Medical College and Hospital, Near M.G. Polytechnic College, Agra Road, Distt. Hathras-204101, Uttar Pradesh** (Inst. Id-AYU00378) is hereby **regularized for academic session 2021-22** to protect the interest of the admitted students **with a warning to the college to maintain the required minimum standards as specified under the concerned regulations of the NCISM Act 2020, the non-compliance of which shall be liable for punishment as per section 28 (1) (f) of NCISM Act 2020.**
7. Please acknowledge the receipt of this letter.
